Safeguarding Office Arrangements during the COVID-19 Health Crisis

During this current health crisis of Covid-19, there will be no safeguarding staff based at the Safeguarding Office, (120 Cliftonville Road) and only limited access to the two remaining staff, who will be working remotely from home.

The Safeguarding Office is now limited to responding to **urgent matters only**, namely, case management and referrals of a safeguarding nature.

If you have an **urgent safeguarding matter** and wish to speak to someone you should always in the first instance, contact either, the police service by ringing 999 in an emergency situation, or if not an emergency, on 101 or the local social services office, whose contact details can be found on the safeguarding website:

*Please note, the office telephone <u>will not</u> be manned during this time, although e-mails forwarded to the office, of an urgent safeguarding nature, will be responded to.

This arrangement will remain in place until the end of May 2020 and then reviewed.

Newly appointed Designated Liaison Person For Down and Connor

Hello, I wanted to take this opportunity to introduce myself to all of you. My name is Margaret Burke and I have joined the Down and Connor Diocese Safeguarding Team as the Designated Liaison Person for the Diocese and will be replacing Philip O'Hara who will soon, sadly be leaving the Team.

I am a social worker and have worked in safeguarding children and young people for over 30 years in various roles. Just prior to coming to Down and Connor I worked as a Professional Officer with the Safeguarding Board for Northern Ireland (SBNI). Close links between Down and Connor Diocese and the SBNI have already been established as our Director of Safeguarding Barbara McDermott, Co-Chairs the SBNI Interfaith Group and sits on the SBNI Board.



My key areas of work with the SBNI related to Case Management Reviews where cases are reviewed when children have died or been seriously harmed to identify any learning which can make children and young people safer, the development of Policy and Procedures providing guidance on Safeguarding to all staff who have links to children and young people and the issues of neglect and mental health which are part of the SBNI strategic priorities.

This knowledge and experience will greatly assist me in my role as Designated Liaison Person for the Diocese.

I am looking forward to working in Down and Connor and to working with you all. I am based at the Down and Connor Safeguarding Office, 120 Cliftonville Road, Belfast, BT14 6LA but currently working remotely from home, given the current situation with Covid-19. Once things get back to normal, I plan to go around the parishes and meet with Parish Priests and Chairs of Parish Safeguarding Committees.

Vetting Office Update

COVID-19 continues to present an ever-increasing threat to the health and wellbeing of everyone, as well as creating increasing disruption to our everyday lives, including our working lives. With major disruption of normal day to day activities within the Parishes and the various Diocesan Offices, it has become impossible for many of our Church staff to continue to carry out their normal work activities.

The priority for Trustees of the Dioceses continues to be the safety and welfare of each employee and in line with these circumstances, the Church Authorities have decided that all staff in the Northern Vetting Office will be Furloughed. In line with the regulations of the Furloughing Scheme it will not be possible for any of the Vetting Office Staff to undertake any work for, or in connection with Northern Vetting.

The Vetting Staff/Office will cease all work from close of play, **Friday 17 April 2020** and we will not be available to respond to correspondence or emails after that date.

Lorraine, Denise and I would like to say, at this difficult time, that we wish everyone safety and good health and we hope to be back fresh and well when the time is right.

As someone said in a letter I received today 'stay at home, protect the NHS and save lives.'


Neglect is the failure to provide for a child and young person's basic needs. Neglect remains one of the most prevalent forms of child maltreatment and is likely to result in the serious impairment of a child and young person's health or development.

The SBNI Neglect Sub-Group in accordance with the Neglect Strategy developed by the SBNI, put together some information on the 'Profile of Neglect in Northern Ireland' to help raise awareness of the issue. Please see profile below:

Profile of Neglect in Northern Ireland








*Tips for keeping your children and young people safe online

- 1 Keep the conversation going Open conversation is always a good starting point
- 2 Keep your computer in a common area of the house. ... In that way everyone knows what going on
- 3 Know which other computers your children are using. ... Think about the mobile phone...it's the mini computer!
- 4 Remind your children, "Don't talk to strangers online or meet them" ... the online world is the same as the offline world
- 5 Make Internet time family time. ... Enjoy the enormous benefits of social media
- 6 Know your children's passwords. Keep it open keep.... Keep it transparent this avoids any need for secrecy
