## National Board Review of Child Safeguarding

The Apostolic Administrator Archbishop Treanor has invited the National Board for Safeguarding Children in the Catholic Church in Ireland to formally review child safeguarding across our Diocese. This is in compliance of Standard 7 Safeguarding Children Policy and Standards for the Catholic Church in Ireland "Quality Assuring Compliance with the Standards".

There will be two basic elements of the Review;

- 1. The operation and safeguarding processes across our Parishes in the Diocese (Covering Standards 1,5,6 and 7)
- 2. Case Management, how the Diocese responds to suspicions, concerns, knowledge and allegations, (covering Standards 2,3,4 and 7).

The Diocese is currently working with the National Board to agree the process and operation of the Review. It is envisaged that the Review will take place in early spring. Our Parishes will be an integral part of the Review in respect of safeguarding at a local level.

We will be in ongoing communication with Parishes in relation to this Review and we will certainly keep you informed.

for themselves; however, it is important that in working with children/young people, an appropriate adult with relevant skills and competencies participates to support them in developing the code of behaviour. Also share the code of behaviour with parents/carers.

Remember the age requirements for social media



To be eligible to sign up for Instagram, you must be at least 13 years old



To be eligible to sign up for Facebook, you must be at least 13 years old



To sign up for TikTok, you must verify that your age is over 13



To sign up for Snapchat, you must be at least 13 years old





In order to create a YouTube account, you must be at least 13 years old, however you can view access the content without creating an account



To be eligible to sign up to Whatsapp you must be 16 years old
